# SHIPPING WITHIN AUSTRALIA

All prices on our site are displayed in Australian Dollars (AUD), and will be charged in Australian Dollars. Shipping within Australia will take approximately 3 working days for processing and 3 – 8 business days shipping. For delivery within Australia we use Australia Post.

#### SHIPPING INTERNATIONALLY

Life in Balance ships to most destinations around the world and we use Australia Post International post service for all our international orders. Please note: we do not deliver to international PO BOX addresses. For our international customers, all prices on our site are displayed in Australian Dollars (AUD), and will be charged in Australian Dollars. Prices do not include relevant overseas customs duties, foreign taxes or other fees, which may be imposed and this is the responsibility of the customer. Please check with your local customs office for further information.

# HOW MUCH WILL POSTAGE AND PACKAGING COST?

For delivery within Australia we offer shipping from a cost of \$10 AUD for normal post or \$15 AUD for Express Post.

For International delivery, you should receive your order within 14 - 30 working days. If your order has not arrived within the allotted time, please contact the shipping company, using the reference number supplied to you.

If you have special instructions relating to the delivery, please be sure to indicate these when required on the delivery details page as you are checking out.

# RETURNS

# WHAT IS LIFE IN BALANCE'S POLICY ON EXCHANGE AND REFUNDS?

If you wish to return an item simply because you change your mind we will exchange or refund provided you return it within 7 days from the date of purchase, un-opened, un-used and in its original condition with labels/tickets attached and with our original receipt (purchaser must pay for the return shipping). Sale items will only be exchanged, not refunded provided you return it within 7 days from the date of purchase, un-opened, unused and in its original condition with the labels/tickets attached and with our original receipt.

Our 'Change of Mind' Policy

Life in Balance is not legally obligated to give refunds on items or exchange them simply because you have changed your mind about the purchase.

However under our own 'change of mind' policy, if you simply change your mind we do offer a refund or exchange of the value equivalent to the purchase price for most items provided that:

- (a) You return the item within 14 days from the date of purchase; and
- (b) The item is un-opened, un-used and in its original condition; and
- (c) All original labels and tickets are attached to the item; and
- (d) You provide a receipt as proof of purchase; and
- (e) You pay for the return postage

Our 'change of mind' policy does not apply under any circumstances to purchases of the following items:

Sale items or cosmetics.

Our customers' right to a refund of purchase price

Our customers are entitled to a refund if the item is faulty, not of merchantable quality or not fit for its purpose. Our policy under these circumstances is:

You (the customer) are entitled to a refund for items you purchase from Life in Balance if the item is:

- (a) faulty and the fault or defect was not pointed out to you before you purchased it or would not have been apparent to you when you inspected the goods before purchase; or
- (b) not 'of merchantable quality', meaning that it is not of the quality that you reasonably expected when you purchased it, bearing in mind the way the item was described to you before your purchase and also the price of the item; or
- (c) not fit for its purpose, meaning that the item does not do what you reasonably expected it would; and

(e) you return the item within a reasonable time after purchase and provide Life in Balance with proof of purchase, such as your Life in Balance receipt or bank statement. If you do not return the item within a reasonable time, you will not be entitled to a refund at the purchase price but you will be entitled to exchange the goods or have them repaired.

Life in Balance reserves the right to ask you to demonstrate that you did not cause or create the fault in the item.

If you are entitled to a refund but you would prefer to exchange the item for another item(s) of equivalent value to the item, Life in Balance is happy to do this for you.

# **ONLINE CUSTOMERS**

For online customers, the Refund Policy also applies; however please note the following terms and conditions:

#### WITHIN AUSTRALIA

- Contact us via email or mail and advise us of your intention to return an item, please ensure you note what you
  are returning and whether you want an exchange or refund.
- Should you wish to exchange the item for an alternative size or colour, please enclose with your goods, a postage paid, self-addressed bag. Please note: all postage costs will be covered by the customer. If the same item is no longer available, a refund will be provided crediting your original method of payment.
- Once we receive your parcel we will process your return. Refunds will be credited against your original method
  of payment, excluding delivery charges.
